

Commodity Derivatives Segment**Circular No.: MCCIL/COM/1636/2020****Date: April 30, 2020****Subject: Revision in Accreditation period of Warehouse (STEEL LONG) and revision in Warehouse Storage charges**

In terms of the provisions of the Rules, Bye-Laws and Regulations of Metropolitan Clearing Corporation of India Limited ("MCCIL") and in continuation of the Indian Commodities Exchange Limited Circular no. ICEX/C&S/2018/193 dated 27th September 2018 and MCCIL Circular no. **MCCIL/COM/1583/2020** dated 17th March 2020; Clearing Members and constituents of Clearing Corporation/Exchange are hereby notified as under:

Clearing Corporation has issued notification vide circular number **MCCIL/COM/1583/2020** dated 17th March 2020 for the de-accreditation of warehouse for storing and effecting deliveries of Steel Long at Ghaziabad delivery Center w.e.f. 30th April 2020.

Due to the current Covid 19 pandemic and the nationwide lockdown, transportation and logistics services for the movement of goods from / to warehouses have been affected. Keeping in view of the same, MCCIL has decided to extend the accreditation period of the said warehouse up to 31st May 2020.

The beneficiary holders are requested to discuss with the warehouse manager (Mr. Vedpal Hooda - 9643201051) and lift the goods latest by 31st May 2020 from the warehouse. The Exchange/Clearing Corporation will not be liable for any loss in respect of the FED goods stored in the Warehouse.

Based on deliberations and consent there upon from the current beneficiary holders to lift the goods on or before 31st May 2020, MCCIL has also decided to revise the storage charges with effect from 1st May 2020. One full month Warehouse charges shall be payable during the extended period irrespective of lifting the goods on any day during the period 1st May to 31st May 2020. The accreditation period is extended only to facilitate the storage of the goods kept already in the warehouse during the extended period; accordingly no fresh deposit of Steel long will be accepted at the warehouse for effective delivery.

The details of revised warehouse Storage charges are given in Annexure.
