## Circular No. : MCCIL/COM/1124/2018

#### **Sub: Grading Agency and Charges**

In terms of provisions of the Rules, Bye-Laws and Regulations of the Metropolitan Clearing Corporation of India Limited (MCCIL) and in continuation to ICEX Circular No. ICEX/C&S/2018/150 and ICEX/C&S/2018/169 issued on May 25, 2018 and July 27, 2018 respectively, members are hereby notified as under:

MCCIL will accept grading report only from "International Institute of Diamond Grading and Research (Hereinafter referred to as "IIDGR"). This grading agency will provide services of grading, testing, inscription and packaging of Diamond stones. The details of applicable grading charges are given below:

FROM (Carat)	TO (Carat)	Grading Fee & sealing Fee (in INR)	Remarks
1.00	1.49	10500	Full Grading Report shall be issued
0.50	0.99	7500	Full Grading Report shall be issued
0.30	0.49	4500	Full Grading Report shall be issued

The other terms and conditions mentioned in the earlier circulars will remain same.

This circular shall be applicable with effect from 8th October 2018.

Note:

- The stones those are found not to be within the ICEX quality parameters shall not be sealed.
- Even, in-case the stone found to be as per ICEX quality, but due to space constraint the inscription number cannot be inscribed then the stone will be returned back to the depositor.
- All the charges (grading + vaulting + stone handling charges) of the client/TM/CM shall be collected

from their respective clearing members on a monthly basis. However, MCCIL reserves the right to ask for early payment/deposit of the said charges.

• These fees/charges shall be debited to the Dues account of the clearing members in the first week of the succeeding month.

• The Re-check, **rejection**, re-print, full evaluation charges shall be intimated to the customer as and when they require it.
