### **Auction Notice of diamond stones**

Indian Commodity Exchange Limited (ICEX) and Metropolitan Clearing Corporation of India Limited (MCCIL) have decided to conduct an auction of diamond stones (1 CT / 0.50 CT / 0.30 CT) lying with the diamond vault service provider (Malca-Amit JK Logistics Pvt. Ltd, Surat). The auction process will be open from 15/09/2022 to 19/09/2022 and the details of the diamond stones proposed to be auctioned are given in Annexure 1.

After considering all the bids received in proper format, the best bid price for the diamond stones will be considered as the successful bids. The successful bidders will be intimated by the ICEX / MCCIL regarding the amount payable and the bid amount is required to be arranged by funds transfer to the account of the MCCIL, within 2 working days from the date of intimation. Along with the bid amount, the successful bidder needs to pay vault delivery charges of Rs 750/- per diamond stone and the applicable taxes.

Upon receipt of funds i.e. bid amount, delivery charges and the applicable taxes, the MCCIL will arrange for issuing release orders to the safe vault. The successful bidder has to submit to the MCCIL, an Authorization Request for taking delivery, in the format as will be provided by the MCCIL and also copies of identity proof [PAN / Aadhar] of the person(s) who will take delivery of the diamond stones from the safe vault in Surat. The persons who take delivery need to carry the original of such identity proof and should take delivery within the prescribed time.
